IN THE LAST 24 YEARS, WE HAVE ADOPTED OVER 8,700 CATS. WE ASSIST PEOPLE IN OUR COMMUNITY THROUGH FAMILY ORIENTED, THOUGHTFUL ADOPTION PROGRAMS AND MANY EDUCATIONAL SERVICES. WE PROVIDE MEDICAL CARE, VACCINES, TESTING AND STERILIZATION TO THESE 872 CATS PREVENTING THE BIRTHS OF HUNDREDS OF CATS IN OUR COMMUNITY. CATS, FOR WHICH THERE ARE NO HOMES. WE WORK WITH OUR LARGEST EUTHANIZING SHELTER TO REDUCE THE EUTHANASIA RATES IN OUR COMMUNITY BY TAKING 236 CATS FROM THEM THIS YEAR, AND THROUGH COOPERATIVE PROGRAMS AND TNR (TRAP/NEUTER/RELEASE) PROGRAMS FOR COMMUNITY CATS. AS THE COMMUNITY'S OLDEST NO-KILL SHELTER, WE SAVE ALL THE ADOPTABLE, TREATABLE AND RECOVERABLE CATS AND KITTENS. WE CONTINUE TO RESCUE CATS FROM HOARDERS, RESEARCH

THIS YEAR, WE STERILIZED 1,859 CATS AND KITTENS THROUGH THE CLINIC. THROUGH EDUCATION WE ARE TEACHING PEOPLE ABOUT TNR
